INSTRUCTIONS:

1. *Both the Objective Final Exam (OFE) and the Subjective Final Exam (SFE) must be completed within the allocated time (i.e., 7:00 - 8:40 PM). Additionally, the OFE must be completed prior to starting the SFE. Both exams are closed book, solo exams.*
2. Grades will be posted to BlackBoard no later than 5:00 PM Friday, May 5. An email notice of the posting will be sent.
3. **The SFE is worth 15% of the course grade as is the OFE.**
There is NO APPEAL of the grading of the SFE.
4. This SFE has *four essay questions*. At the start of a student's SFE that student will be *assigned two of those four essay* questions to answer.
5. A student's answer to a **SFE** essay question will be **graded based on** the student's **demonstrated mastery of the *Introduction to Legal and Economic Analysis*** text.
6. The four questions are *drawn from* the volume 18, number 3, May-June 2005 issue of *World*Watch* magazine. You may obtain paper copies from some major local bookstores, some local libraries, or you may obtain PDF copies of the main articles from the World*Watch web site.

7. Your **answers** to the essay questions shall be **typed during the exam time**. The OFE and the SFE will be administered in RH 406, a computer classroom. **It is academic dishonesty to:** [a] during the SFE access the web; or [b] during the SFE access (other than mentally) previously crafted answers.
8. Each essay question is in the form of a statement. Each answer shall start with a single sentence paragraph of in the form: "#1: SUPPORT." or "#1: OPPOSE."
The answer then shall persuade the reader to adopt that stance.
9. Each answer shall use **two typed pages**, and no more. Set your **margins at 1"** on all four sides. Set your font face to **Georgia 12**. Set your line spacing to **double spacing**. Set you **header** to display your last name at the left margin and to display Page X of Y at the right margin. Use a **tab** to start a paragraph.
Start your first answer at the top of page 1 and start your second answer at the top of page 3.

QUESTIONS:

- 1.** Increasing the percent of seeds used in agriculture that are patented seeds is good for consumers.
- 2.** When a domestic corporation is convicted of a USA State crime, and that crime has imprisonment as one of its penalties, then the corporation's Chief Executive Officer shall serve the sentence, unless some other officer, member of the Board of Directors, or 10% shareholder is found by the trier of fact, beyond a reasonable doubt, to be more culpable.
- 3.** Any person who introduces via an unlawful act a genetically modified organism into Earth's ecosystem located in a USA State, when done with scienter, shall be punishable by that State's death penalty.
- 4.** Both a Reasonable Person lender and a Rational Person borrower must use the precautionary principle to discharge both fiduciary duties and ethical duties.
